Type I Development Permit to construct a detached garage located at 5435 Childs Road was approved unanimously.

An Ordinance You May Not Be Aware Of

It has been brought to Council's attention that one of Rivergrove's Land Use Ordinances has been overlooked by a few residents in the City. Heres's the Ordinance:

Section 2.040 Exclusions From Development Permit Requirement. An activity or development listed below is excluded from the requirement for a development permit:

d) Erection of a tent or similar portable temporary structure provided that the structure is in place for no more than 3 months per calendar year.

Such structures include tent frames serving as carports or boat storage. Also included are PODs (storage comartments for shipping). In other words, if your temporary structure is to be there less that 3 months in a calendar year, you are fine. But temporary structures such as canvas carports and shipping PODs are not allowed at all in Rivergrove, beyond this three-month period. Thank you!
