City Council

At the special meeting on April 13th the council heard testimony from several residents. Items of concern included the need for transparency about the change in proposed projects for the Coronavirus funds, more public input, adequate public notice, responsible budgeting and park stewardship, a call for a master parks plan, and questions about abandoning the proposed Stark boat ramp signage project.

After listening to citizen testimony, the council addressed concerns reminding citizens of campaign promises of action and transparency and the justification for abandoned projects.

After discussing their top choices for the Coronavirus funds, the council moved to approve the Stark Boat Ramp restoration bid with On Demand Excavation 4-1, the bid from Caldwell Landscaping to improve Lloyd Minor Park (5-0) and also to fulfill the city's obligation to make the pathway between Lorna Lane and Dogwood Ct ADA compliant by approving the bid from J&J Casta, LLC (5-0).

Councilor Tuttle requested input from citizens to create formal park plans while Councilor McLean requested to discuss the removing the Stark boat ramp gate altogether at the next CC meeting.

Planning Commission

On April 19th the Planning Commission heard two Type III development permit application requests. The first, at 4546 Dogwood Drive for a floating dock whose application was deemed incomplete at the previous meeting. After submitting a more scaled drawing which accounted for the embankment trees, The Planning Commission deemed the application complete and approved the dock 3-0. There were no objections by the public.

Next, the Commission continued the hearing for the Type III development permit application for 4810 Dogwood Drive. Previously the applicant was asked to provide a response to, among other things, the city arborist written concerns about the number of trees removed and the protection zones of neighboring trees. Citizens raised concerns about their trees, the increased area flooding potential as well as the difficulty in obtaining timely information to evaluate.

The PC deemed the application complete and conditionally approved the applicant request for a hardship variance as noted on the Notice of Decision (NOD). Currently, two citizens have issued an appeal. An Appeal Hearing by the City Council will be announced shortly.
