## Planning Commission and City Council Topics

### **TYPE IV PUBLIC HEARINGS FOR ORDINANCE 87-2014 AMENDING COMPREHENSIVE PLAN GOAL #12**

On Monday November 3 and November 10 at 7:00 pm in the River Grove School library, type IV public hearings will be held for the adoption of Ordinance #85-2014, a revision of Rivergrove's Comprehensive Plan Goal #12: Transportation. This ordinance will amend Ordinance #79-2011, an ordinance repealing the Rivergrove Comprehensive Plan (Attachment B to ordinance 54-89) and adopting a new Rivergrove Comprehensive Plan. The procedures followed will be pursuant to Rivergrove Land Use Ordinance sections 4.120 and 6.225-6.229. ## Mayor's Message

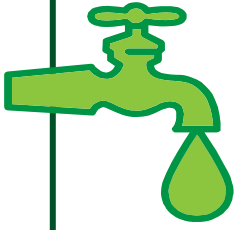
